

TICKET TERMS AND CONDITIONS

These Ticket Terms and Conditions (“Conditions”) govern all Tickets issued for an affiliate meetup, called **"Test Org Metup", held on February 28, 2024** (“Meetup”) and the subsequent admission to Venue to attend the **Meetup**.

For the purposes of these Conditions,

"Ticket(s)" means a ticket/tickets giving right of entrance to the Meetup at a particular Venue in accordance with the information stated thereon;

"Ticket Holder" means any individual holding or who has held, a Ticket, including without limitation, the person to whom the Ticket was issued;

"Meetup" means affiliate meetup, called **"Test Org Metup", held on February 28, 2024** (“Meetup”), at **MISS TESS in Taj Dubai - Burj Khalifa St - Business Bay - Dubai - United Arab Emirates**

"Participant" - means any physical entity intending to select/purchase the chosen Ticket option (type).

All Tickets are issued by **Conf Disco Limited, Gibraltar, G00 1AB, Reg.No: 0001, hereinafter “CDL”**);

Any person who purchases, possesses and/or uses or attempts to use any Ticket shall be deemed to have accepted, and agreed to comply with, these Conditions.

GENERAL

1. These Conditions are deemed to incorporate the rules and regulations of [Regtoevent.com](https://regtoevent.com) (the event ticketing company) and the venue at which the Meetup is held ("Venue"). In case of any conflict between these Conditions and such rules and regulations, these Conditions will prevail.
2. Tickets may only be purchased through **CDL**.
3. The original Ticket Holder is responsible for ensuring anyone they provide a ticket to is fully aware of and complies with these Conditions.

PRICES AND PAYMENT

1. Tickets are available in two variants: **Ticket and VIP Ticket**. The description and requirements for the Participant in each variant (type) of the Ticket are posted on the Site. The Participant chooses the appropriate variant (type) of the Ticket according to the specified requirements.
2. Payment shall take place in the manner stated on the **CDL** website. Information on ticket prices and availability, stated on the website.
3. All prices as stated on the **CDL** website **are in USD, unless expressly stated otherwise**.

REGISTRATION ON THE WEBSITE

1. Registration and purchase of the Ticket for the Meetup is preceded by mandatory registration on the Website. Registration is carried out by filling out the registration form on the Website. The registration form must contain the Participant's full name, e-mail address, Telegram login, phone number and optionally other data in accordance with the selected Ticket type.

BREACH OF CONDITIONS

Any breach of any Condition may, in addition to any other remedy CDL may have, and even if the holder of the Ticket did not have notice of the Condition or the breach, result in refusal of entry, eviction/expulsion from the Venue, cancellation or voiding of the Ticket and the cancellation of any other Tickets held or purchased for the Meetup without refund or compensation of any kind. In addition, CDL may impose sanctions including, but not limited to, banning or prohibiting the original purchaser from purchasing tickets to future CDL events or refusing to sell or supply Tickets in future to persons found to have breached these Conditions.

ENTRANCE TO THE VENUE

1. Entry to the Venue will only be authorized upon presentation of a valid Ticket or a specific bracelet and, upon request, proof of identity with valid photograph and signature. Ticket Holders must comply with the security protocols in place at the Venue as well as any applicable health and safety or security regulations.
2. One Ticket will be required for each person.
3. Entrance to the Venue may be refused to any person noticeably under the influence of alcohol, narcotics, or any behavior-modifying substance, or to any person behaving, or considered likely to behave, violently, harmfully, or contrary to public order. Any person noticeably under the influence of alcohol, narcotics, or any behavior-modifying substance, or to any person behaving, or considered likely to behave, violently, harmfully, or contrary to public order within the Venue will be ejected.
4. Ticket Holders agree that it is an essential condition of issuance of Tickets and the right of admission to the Meetup conferred on the Ticket Holder that any person at, or entering, the Venue is, without limitation, expressly prohibited from:
 - holding or bringing any prohibited or restricted items (to be assessed at the discretion of stewards, security, safety personnel and/or any other persons legally authorized to take such steps at the Venue ("Authorized Persons") including, without limitation, glass, cans, weapons, fireworks, hard cool boxes, compressed gas containers, flares, air horns, smoke bombs and flag sticks; alcohol and/or illegal substances; political, religious, offensive or race-related banners, signs, slogans or materials; any unmanned aerial vehicles and/or any other flying objects generally known as drones; and items that are dangerous, may be used as a weapon or may interfere with the enjoyment, comfort or safety of other persons or security at the Venue ("Prohibited Items");
 - using, possessing or holding promotional or commercial objects and materials, engaging in any ambush marketing (or holding or bringing any items, objects, signs or materials which CDL or any Authorized Person believe are intended to be used for the purposes of ambush marketing), gambling (or assisting any gambling activity), conducting any commercial activity, offering (either for free or

for sale), selling or possessing goods with intent to sell such as drinks, food, souvenirs, clothes, promotional and/or commercial items, without prior written approval of **CDL**. All such items, or other Prohibited Items, may be removed or confiscated (temporarily or for destruction) by the Authorized Persons;

- engaging in disruptive or dangerous behavior including, without limitation propelling, throwing, casting, thrusting or firing any objects, engaging in or instigating violence, racism or xenophobia, behaving in a way that others may interpret as provocative, threatening, discriminatory, abusive or offensive, creating any threat to the life or safety of themselves or others, or harming another person in any way whatsoever, climbing apparatus or constructions, or standing on seats;
- entering or circulating in restricted access areas or other areas where that person is not permitted, including the playing enclosure.

SAFETY AND SECURITY

For the purpose of safety, security and checking compliance with these Conditions, all persons attending a Meetup shall, if requested by any Authorized Persons, co-operate by:

- providing a valid Ticket and proof of identity with valid photograph and signature;
- submitting to a search of possessions and/or body checks for the purposes of locating and removing Prohibited Items;
- relocating to a similar seat if required by such personnel for operational reasons;
- complying with the instructions and guidelines of such personnel.

LIMITATION OF LIABILITY

1. Any person attending a Meetup acknowledges that his/her presence and/or movement in and around the Venue is at his/her own risk and that to the maximum extent permitted by law, **CDL**, Authorized Persons or any other relevant body cannot be held liable for any loss and/or harm, including but not limited to bodily or mental harm, personal property damage or loss, or any other loss and/or harm arising from and/or occurring during attendance at the Venue, and without limitation to the foregoing, no claim, complaint or proceeding will be brought by Ticket Holders in relation to the foregoing.

2. Ticket Holders acknowledge that they are individually responsible for their own property and there is no storage available at Venues.

INDEMNIFICATION

Ticket Holders will indemnify and hold **CDL**, Venue and Authorized Persons or any other relevant body harmless from and against all damages and liabilities suffered or incurred in connection with, resulting from, or arising out of, a breach of these Conditions.

CANCELATION POLICY AND REFUND

1. In case of cancellation 14 calendar days before the date of the Meetup, no commission will be applied.
2. In case of cancellation 10 calendar days before the date of the Meetup, a cancellation fee of 50% of the ticket price will be applied and the balance (50%) will be refunded.
3. In case of cancellation 7 calendar days before the date of the Meetup, no cancellation will be allowed and no refunds will be made.

MEETUP CANCELING AND ALTERATIONS

CDL reserves the right to cancel Meetup or make alterations to the times, dates and Venues of the Meetup or other details governed by any Ticket in the event of unforeseen or other circumstances, including without limitation, force majeure, safety and security concerns or decisions from any other competent authority. In the event of such alteration, **CDL** will not be liable to the Ticket Holder or any other person for any loss resulting from such change.

In the event that Meetup is cancelled, or Ticket Holders are not permitted to attend the Meetup, any entitlement to a refund or compensation to which a Ticket Holder may be entitled (which in any event shall not exceed the face-value of the Ticket) shall be strictly governed by the refund/compensation process which shall be established by **CDL** for the purposes of the Meetup.

PHOTOGRAPHS AND OTHER RECORDING

1. Photographs or any other recording of sound or images taken within the Venue may be used only for personal, private non-commercial purposes. It is forbidden to disseminate over the Internet, radio, television or any other current and/or future media, any sound, image, description of the Meetup in whole or in part, or assist any other person(s) conducting such activities. Making, or distribution of, broadcasts, commentary, news reports (by any means in any format or media including any such content made, recorded, or captured in still or moving form by mobile phone or other wireless device) is also forbidden.
2. Any person attending a Meetup:
 - acknowledges that broadcasters may be operating drones (remotely piloted aircraft systems) in and around the Venue;
 - acknowledges that it is likely to be recorded in a number of media and publicly disseminated;
 - agrees that perpetual use may be made, free of charge, of his/her voice, image and likeness whilst at the Venue, by means of live or recorded video display, broadcast, transmission or other dissemination or recording, photographs or any other current and/or future media technologies;
 - waives, on an irrevocable, worldwide, perpetual basis, all rights to object to such broadcasting, transmission, or dissemination in any media;
 - acknowledges and agrees that **CDL** is the sole legal and beneficial owner of the copyright and any other intellectual property rights of any nature whatsoever in and to any recordings of sound or

images taken within a Venue (including future rights to such recordings or to any works derived from such recordings) and waives, on an irrevocable, worldwide and perpetual basis, all rights (including moral rights) in and to any such recordings;

- hereby unconditionally and irrevocably grants to **CDL** a perpetual, exclusive, freely assignable and royalty-free and worldwide licence to use, adapt, distribute and/or exploit, by any means and in any current and/or future form or type of media or format, any recordings taken by the Ticket Holder within a Venue in breach of these Conditions.

PERSONAL INFORMATION

1. The Ticket Holder agrees that their personal information provided to **CDL** by the Participant may be processed and stored by **CDL** as necessary for the performing of the contract evidenced by these Conditions, including for the purposes of the implementation of these Conditions and for administration, communication, enforcement and access control purposes related to the Meetup. Ticket holders, acknowledge and understand that **CDL** may provide their personal information to the third persons in connection with such purposes. The Participant has a right of access to, and correction of, his/her personal information.

SEVERABILITY

1. In the event that any provision(s) of these Conditions be declared void, ineffective or unenforceable by any competent court, the remainder of these Conditions will remain in effect as if such void, ineffective or unenforceable provision(s) had not been included.

2. **CDL** reserves the right to make amendments to these Conditions from time to time, which updated version will be available at the Website.

GOVERNING LAW

These Conditions will be governed by and interpreted in accordance with applicable laws of the EU. All disputes arising from or related to these Conditions will be submitted to the competent Court in Cyprus. Nevertheless, CDL reserves the right to pursue any legal proceeding in the competent courts at the defendant's domicile.
